





Academic Integrity Cases



Number of Reported Cases & Violations to the Academic Integrity Policy 2001-2009






Number of Academic Integrity Violations between 1987-2009

VIOLATIONS TO THE ACADEMIC INTEGRITY POLICY STATISTICAL REPORT 2009-2010

Summary

During the 2009-2010 academic year, 232 reports of violations to the Academic Integrity Policy were filed with the Office of Student Conduct & Ethical Development. Seventy seven (77) were for incidents of cheating. The remaining one hundred fifty five (155) were for plagiarism.












Office of Student Conduct & Ethical Development 2012 -2013 Statistics







Academic Integrity Cases

In 2012-2013 academic year, 264 reports of violations to the Academic Integrity Policy were filed with the Office of Student Conduct & Ethical Development. Of those reports, 111 were for incidents of cheating and 153 were for plagiarism.
