





To be successful, broad community engagement with the CMP is a must! Our planning process will include numerous and ongoing opportunities for the campus and community to engage in this three-year initiative.






Over the span of the project, faculty will be using the Campus Master Plan as a teaching tool in related courses.


The Campus Master Plan is a special opportunity to closely examine the built environment and the campus context, for which there are teachable skills that apply.
