Chosen topics will directly relate to readings. A set time frame will be in place for posting of comments and replies, <u>students will only be able to post during said time frames</u>. Full credit (i.e., points) for each posted topic will require at least (2) substantive posts, one original post and one reply to another student's post. See course schedule and check canvas.
