The course presents historical and modern perspectives of the theories and structures of law, and provides an overview of the economic and sociological challenges to law making. This course also examines the nexus between law, social change, and dispute resolution. 3 Units.

Course Requirements and Assignments

Our class is offered on campus and in-person. Students are encouraged to review questions and subject matter in class, during regularly scheduled Office Hours on Zoom, and/or via email. Success in this course is based on the expectation that students will spend, for each unit of credit, a minimum of 45 hours over the length of the course (normally three hours per unit per week) for instruction, preparation/studying, or course related activities, including but not limited to internships, labs, and clinical practica. Other course structures will have equivalent workload expectations as described in the syllabus.

Weekly Assignments

Students will be assigned **seven** weekly reading and writing assignments in class and as reflected below. Weekly Assignments are due during every other **Wednesday** class session, or as instructed, and will consist of a three-to-five paged double spaced typed analysis in 12-point font. Quizzes

Students will complete a total of **seven** quizzes throughout the semester to be administered at the conclusion of every other **Wednesday** class session, or as instructed, in response to subject matter from class lecture. (CLO 1, 2, 3 & 5)

Final Examination
