Caste Project – Individually or with a partner, construct a narrated slide show presentation that summarizes a chosen aspect of the American "caste system" (CLOs 1-5)

Book Journal – Answer a series of questions about the socio-legal construction of race as you read the book, *White by Law.* (CLOs 1 & 2)
