## A. Approve 2025 Student Union Health Benefits Schedule and Employer Contribution

Mr. Burgess discussed the increases to the health benefit plans and recommended an increase of 10.45% to the employer's contribution. The budget included up to an 11% employer contribution so an increase of 10.45% is within the approved budget. Mr. Burgess reviewed a spreadsheet that included the employee and employer costs for the different health plans offered for 2025 and the increased



costs from 2024. There was no increase to the vision benefits but the dental benefits increased by 3.9% which will be absorbed by the employer costs. The employee will continue to have no contribution costs for dental and vision.

Ms. Sasikumar asked if the numbers received were derived from the system-level numbers. Mr. Burgess explained that the premiums for each benefit comes from the system level.

Director Johal asked for a motion.

Director Dogra motioned to approve the 2025 Student Union health benefit rates and employer contribution; Director Fuentes-Martin seconded the motion.
