## Law Enforcement - UPD

SJSU's Police Department (UPD) investigates reports of sexual violence, dating violence, domestic violence, and stalking for potential criminal prosecution. If the incident occurred outside UPD's jurisdiction, UPD will refer the investigation to the law enforcement agency with appropriate investigative authority. A report to UPD does not require the name of a survivor or perpetrator be identified to the campus.
